## **SEAT RESERVATION AND TUITION AGREEMENT**

Students will be enrolled after the non-refundable \$100.00 reservation deposit and completed Reservation and Tuition Agreement have been received by Faith Islamic Academy (FIA) administration.

## **Application Fees**

Application Fees are \$100 per child. This fee is non-refundable and will NOT be applied towards the tuition. It is to be paid with the application.

## **Registration Dates and Registration Fees**

Admission for Faith Islamic Academy's current students is open from March 20<sup>th</sup> until April 20<sup>th</sup> of each year with discounted admission fee. The regular admission fee will be applied starting April 21<sup>st</sup> until June 5<sup>th</sup>. For new students, the open enrollment period is from April 21<sup>st</sup> to June 5<sup>th</sup>, in which case the regular admission fee is applied. If any of the previous set dates falls on a weekend or a holiday, the next business day will be considered instead. Please keep in mind that we have few available seats in every class. The school is adhering to a first-come, first-served policy.

### **Tuition**

The typical education cost for each child is more than \$7,500 per year. FIA, through an agreement with ISAK is subsidizing the tuition paid by families. However, we encourage parents who can pay more to do so to extend and maximize the financial support benefit to most FIA families. FIA awards internal scholarships from general donations according to an established process independently administered by its scholarship committee (see Parent-Student Handbook).

#### **Discounts**

- Registration fees are discounted 25% for existing students who are registered by April 22<sup>nd</sup> of the current year for the following school year. If the April 22<sup>nd</sup> date falls on a weekend or a holiday, the next business day will be considered as the alternate deadline.
- FIA through internal agreements with The Islamic Society of Akron and Kent (ISAK) graciously offers subsidized tuitions to its Family Members. To benefit from the subsidized FIA tuition schedule, the ISAK membership fees must be paid by <u>January 31<sup>st</sup> of each year</u> for existing families. New Families must pay the ISAK membership <u>upon registration</u> of their children at FIA. Parents who do not pay the annual ISAK membership to FIA will be subjected to the non-subsidized full tuition schedule.
- Tuition discounts are offered for children of school employees, who will have a 50% discount on the 1st child and a 25% on each subsequent child.
- No other discounts will be offered.
